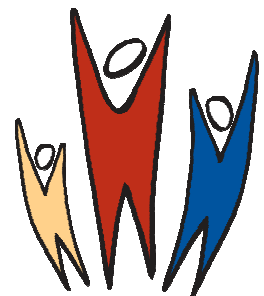
It's easy!

I authorize Independent School District 200 ("ISD 200") to deduct the amount selected below from each of my paychecks and direct ISD 200 to remit my payroll deduction amount, as soon as administratively practicable, to the Hastings Public Schools Foundation, a nonprofit 501(c)(3) corporation ("HPSF"). This agreement remains in effect until I revoke or modify it. I may revoke or modify my payroll deduction as of any day. However, to revoke or modify my payroll deduction, I must provide the ISD 200 Payroll Department at least 30 days advance written notice of my revocation or modification, specifying the effective date of the revocation or modification. By signing this agreement, I authorize ISD 200 to share my name, address and donation amount with HPSF. HPSF does not disclose donation amounts to anyone other than its accounting staff. Unless a donor requests to remain anonymous, HPSF does periodically publish the names (but not the donation amounts) of its supporters. If you wish to remain anonymous, please send an email to the HPSF staff, jlanglais@hastingspsf.org. Your HPSF payroll deduction contributions are tax deductible. Annual gift acknowledgments will be provided by HPSF for tax purposes.
